



Twin Valley Co-op's 2025 Treasure Hunt

Official Contest Rules and Regulations ("Rules")

Twin Valley Co-op Treasure Hunt (the "**Contest**") is sponsored by Twin Valley Co-op Ltd. (the "**Sponsor**") and will be administered by the Sponsor. The contest begins at 12:00:00 am CT (Central Time) on January 1, 2025 (the "**Contest Start Date**") and ends 11:59:59 pm CT on December 31, 2025 (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. **HOW TO ENTER:**

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

To enter and receive (1) contest entry use one of the following methods:

In Store – Record your name and phone number on your till receipt provided to you at the time of purchase and enter it as per the month's directions, in one of our ballot boxes locations. Please ensure that your printing is legible. One entry per till slip. Till Slips must be dated in the month they are being entered.

No Purchase Necessary - Send a letter including your name, address, city/town, postal code, phone number and email address to the following address:

The letter must include 500 words explaining why Twin Valley Co-op is your local shopping choice. All no purchase necessary entries must be received on or before the end of each month.

2. **ELIGIBILITY:**

Eligible

To enter the contest and be eligible to win the prize, a person must be a resident of Canada and the age of majority in the jurisdiction in which they reside as of the Contest Start Date.

Not Eligible

The sponsor's Employees, Board of Directors and immediate family members (within the same household) are not eligible to participate in the Contest or win prizes in the Contest.

The chance of being selected is dependent on the total number of eligible entries received during the Contest Period.

4. PRIZE WINNER:

A random draw will be made the first week following the month end of the giveaway. (Example: January draw will take place Tuesday February 4) from all the eligible entries received on or before the Contest Closing Date. Locations will vary throughout Twin Valley Co-op. There will only be one winner each month. Selected entrant will be contacted by phone within 7 business days of the draw by a representative of the Sponsor. If the selected entrant cannot be contacted within seven business days his/her entry will be disqualified and another entrant will be randomly selected. To be declared a prize winner (the **"Prize Winner"**), the selected entrant must: correctly answer a mathematical skill testing question to be administered via telephone. The prize winner will be responsible for pickup/delivery of the prize. The prize must be picked up within 14 days of being declared the prize winner.

5. GENERAL:

- i. Verification. Entries made without purchase are subject to verification by the Sponsor. Any entry that is incomplete, incomprehensible, inaudible, illegible, fraudulent, mutilated, late, or which does not comply with the rules outlined here will automatically be rejected and will not entitle a person to an entry into the contest.
- ii. Disqualification. The Sponsor reserves the right to disqualify any person or cancel one or more entries of any person entering this contest or who attempts to participate by means contrary to the rules herein or in a manner prejudicial to other participants (e.g., use of Entry Forms obtained from an unauthorized source, entries exceeding the allowable limit, computer hacking, etc.).
- iii. Non-compliance/eligibility. By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest. Refusal to accept a Prize. The refusal of a person selected at random to accept a Prize according to the terms herein releases the Sponsor from any obligation related to Prize to that person.
- v. Substitution of a Prize. The Sponsor reserves the right to award a Prize (or a portion of the prize) of similar nature and equivalent value or, at their sole discretion, the value of the Prize (or a portion of the Prize) indicated herein in cash, without any liability to Sponsor.

- vi. Responsibility – operation of the Contest. The Sponsor is not liable to the following: malfunctioning of any computer component, software or communications line; any faulty, incomplete, or incomprehensible transaction or any transaction erased by any computer or any network, and which may limit or prevent any person from entering the Contest; any technical or human error which may occur in the treatment of or participation in the Contest; problems with the functioning of the website or features of the website, regardless of cause; malfunction or damage to the telephone network or lines, to computer equipment, to voice mail machines or systems, to data or software, to online systems, servers or access providers; any loss of function because witnesses are not activated; congestion on the Internet; the security or privacy of information transmitted via computer or telephone networks; or any breach of privacy due to interference by hackers.
- vii. Authorization. By entering this Contest, any Prize Winner authorizes the Sponsor and their representatives to use, if required, their name, photograph, image, declaration regarding the Prize, place of residence and/or voice without any form of compensation and at their discretion, without limit as to the period of use in any social media or website and globally, for advertising purposes or any other purpose deemed relevant.
- viii. Personal information. The Sponsor respects your privacy. By entering the Contest you consent to the collection, use and disclosure of your personal information. Subject to Section 12(vii), the personal information provided by participants in connection with this Contest is being and will be used by the Sponsor and/or by third party service providers on behalf of the Sponsor only for the purposes of administrating and conducting this Contest, including determining eligibility and awarding and delivering the Prize, and for no other purpose. No communication, commercial or otherwise, unrelated to this Contest will be sent to a participant, unless the participant expressly authorizes it.
- ix. Decisions of the Sponsor. Any decision of the Sponsor or their representatives regarding this Contest is final and cannot be appealed.
- x. Identification of the participant. For the purposes of the rules, the participant is the person whose name appears on the Entry Form. This is who the Prize will be awarded to if he or she is selected and declared the Prize Winner.
- xi. Jurisdiction. This contest is subject to all applicable local, provincial and federal laws and regulations.
